Events of the North deliver a number of mass participation sports events across the UK. Trading since 2010 under DS Media & Events Ltd, the company now organises four large scale events along with a number of smaller events throughout the year, ranging from 5K runs to Marathons and Duathlons.

SHARING YOUR PERSONAL INFORMATION

We keep your personal information confidential, but may share it for the

purposes/activities set out in the table above with the following:

- selected third parties including:
- event related fulfilment including timing company and mailing house;
- business partners, suppliers and subcontractors for the performance of any contract we enter into with or in relation to you;
- results, including local and specialist media and participant photography services company
- charities (individual charities as selected by you on the entry form);
- advertisers and advertising networks that require personal information to select and serve relevant adverts to vou and others. We do not disclose information about identifiable individuals to our advertisers, but we will provide them with aggregate information about our users. We may also use such aggregate information to help advertisers reach the kind of audience they want to target. We may make use of the personal information we have collected from you to enable us to comply with our advertisers' wishes by displaying their advertisement to that target audience;
- analytics and search engine providers that assist us in the improvement and optimisation of our Website.

We will disclose your personal information to third parties:

- if we are required to do so by law or pursuant to a binding regulatory request (in such circumstances, such disclosure will at all times be solely to the extent required by law or the applicable regulatory request);
- in the event that we sell or buy any business or assets, in which case we will disclose your personal information to the prospective seller or buyer of such business or assets;
- in order to enforce or apply our terms of use and other agreements; or
- to protect the rights, property, or safety of our users, or others which may include exchanging information with third party companies for the purpose of fraud prevention or credit risk reduction.
